WINForms® Renewal Begins March 1st

Monday, March 1st, starts the automatic renewal prompt in the WINForms®/zipForm® 6 software. This is the annual renewal that occurs every March to ensure that users are ACTIVE REALTOR® members and are entitled to this free member benefit. This year, you will not only be prompted to renew your software but to also upgrade to zipForm® 6 if you have not already done so. WINForms® will no longer be supported after March 31, 2010. You may choose to defer the renewal/upgrade throughout the entire month of March. **But as of April 1, 2010 the only option will be to upgrade in order to access the electronic forms.**

We encourage you to upgrade as soon as possible. It will be a less stressful situation to upgrade now rather than wait and not be able to get into the WINForms®
