Online Ed Offers S.A.F.E Required Mortgage Exam

In California there are approximately 44,000 real estate agents required to take the new federally required S.A.F.E. mortgage exam. OnlineEd now provides the exam prep for the S.A.F.E. Exam. In California, if you were a licensed real estate licensee on December 31st, 2009 you are not required to take the actual S.A.F.E. licensing course, only the exam. OnlineEd's course prepares the individual for the exam. Anyone licensed starting on January 1, 2010 will be required to take a California Mortgage Licensing course and also have a real estate license.
