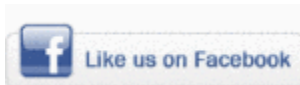

Sustainable Water Agencies can Impact Your Clients (and you)

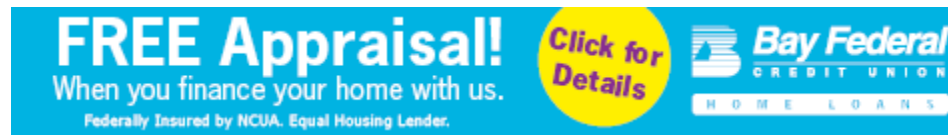
