### **NEWS FROM THE MLS**

Effective June 9th, at the request of MLSListings' Board of

Directors, the calculation of DOM will be modified in the MLSListings database. Currently, the MLS has two calculations for "Days on Market". DOM is set to "0" whenever a listing is entered and an MLS number is assigned. DOM is described as "following the listing". CDOM, on the other hand, "follows the property". CDOM, or "Continuous Days on Market", continues to accrue for a given property until it is SOLD or until it has been expired (Status 6) or cancelled (Status 7) for more than 30 days. #### New Law Requires Disclosure of DRE License Identification Number on all Solicitation Material

Effective July 1, 2009, the law (<u>SB1461</u>) will require a real estate licensee to disclose his or her DRE license number on all "solicitation materials intended to be the first point of contact with consumers" and on real property purchase agreements when acting as an agent in those transactions.

It defines "solicitation materials intended to be the first point of contact with consumers" to include: business cards, stationery, advertising fliers, and other materials designed to solicit the creation of a professional relationship between the licensee and a consumer.

Excluded from the definition are the following: an advertisement in print or electronic media, "for sale" signs, and specified classified rental advertisements.
