### **Code of Ethics Article 16: Interference with Agency**

Article 16 has twenty Standards of Practice that clarify the circumstances under which a REALTOR® may ethically solicit a potential client and interfere with the agency relationship of another REALTOR®. While it is beyond the scope of this essay to describe each Standard of Practice, the reader is referenced to the complete Code of Ethics and urged to read the Standards of Practice to Article 16 in their entirety. Examples of issues covered by Article 16 and its Standards of Practice are:

- Innovative or aggressive business practices;
- Advertising solicitations of agency or other relationships;
- Solicitation of listings from clients of other brokers;
- Dealing with other brokers' clients;
- Obligations of exclusive relationships; and
- Agency and/or brokerage relationship disclosure. Other Agents' Clients

HYPOTHETICAL: Client Nicole gave a 180-day exclusive right to sell listing of a commercial property to REALTOR® Kelly, specifying that no "for sale" sign was to be posted on the property. REALTOR® Kelly began marketing the property, but, after 3 months, had produced no offer to purchase. After REALTOR® Wendy heard about the property at an association luncheon, she paid ...Read more
